

LEGAL NOTICE

IF YOU PURCHASED CERTAIN GROUND COFFEE PRODUCT(S) BETWEEN JANUARY 1, 2016 AND JULY 29, 2020, A CLASS ACTION SETTLEMENT MAY AFFECT YOUR RIGHTS.

Great Value, Bonus Blend, Flavor Peak, Food Lion, Hannaford, Market Pantry, Signature Select Brands

What is this about?

The lawsuit claims that the defendants, Massimo Zanetti Beverage, USA, Mother Parkers Tea & Coffee USA, Ltd., and Reily Foods Company (the "Defendants"), deceptively packaged and labeled Great Value, Bonus Blend, Flavor Peak, Food Lion, Hannaford, Market Pantry, and Signature Select ground coffee Products as containing enough coffee to make a represented number of cups. Defendants deny any wrongdoing. As part of the Settlement, Defendants have agreed to change their Labeling practices and provide payments to customers.

Who is included in the Settlement?

You may be included in the Settlement if you purchased Great Value, Bonus Blend, Flavor Peak, Food Lion, Hannaford, Market Pantry, and/or Signature Select ground coffee Products for personal use between January 1, 2016 and July 29, 2020.

What does the Settlement provide?

The Settlement will provide up to a maximum of \$20,000,000 to pay Valid Claims. Only one Claim may be submitted per Household under either Tier 1 or Tier 2 and final amounts paid may be reduced based on total number of Claims received.

- **Tier 1 - Without Proof of Purchase:** You can get up to \$1.00 per Unit for **up to \$5.00 maximum** per Household.
- **Tier 2 - With Proof of Purchase:** You can get up to \$1.00 per Unit for **up to \$30.00 maximum** per Household.

What are my rights?

- **Submit a Claim** – You must submit a Claim to get a monetary Benefit from this Settlement. Claim Forms must be submitted online or postmarked by **November 18, 2020**.
- **Do Nothing** – If you do nothing, you remain in the Settlement, you give up your rights to sue, and you will not get any money.
- **Exclude Yourself** – This is the only option that allows you to keep your right to sue about the claims in this lawsuit. You will not get any money from the Settlement. Your request for exclusion must be received by **November 2, 2020**.
- **File an Objection** - Stay in the Settlement but tell the Court why you think the Settlement should not be approved. Objections must be submitted by **November 2, 2020**.

The Court will hold a Fairness Hearing in the Circuit Court of Phelps County, Missouri, located at 200 North Main Street, Rolla, Missouri 65401, in the courtroom of the Honorable William E. Hickle, on November 16, 2020, at 9:00 a.m., to decide whether to approve the Settlement and to award Attorneys' Fees and Expenses of up to \$4,700,000, and up to a maximum total amount of \$30,000 in the aggregate to compensate the Class Representatives. All briefs and materials filed in support of the Settlement and the Application for Attorneys' Fees and Expenses will be made available on the Settlement Website at **www.BeckerSettlement.com**. You may hire an attorney, at your own expense, to appear at the hearing, but you don't have to.

Claims will be paid only if the Court approves the Settlement and all appeals are resolved. Please be patient. If the Settlement does not become effective, the litigation will continue.
